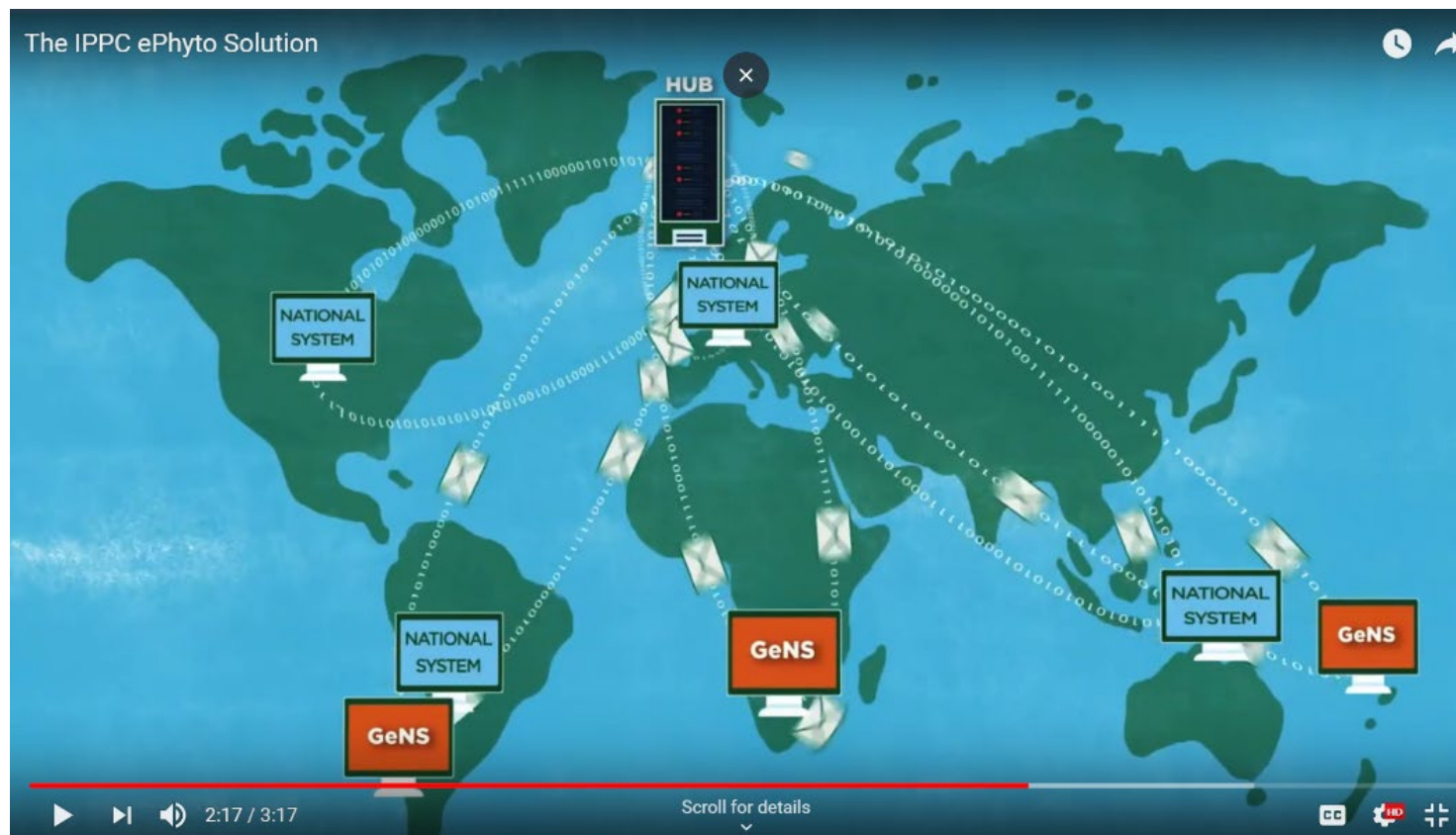

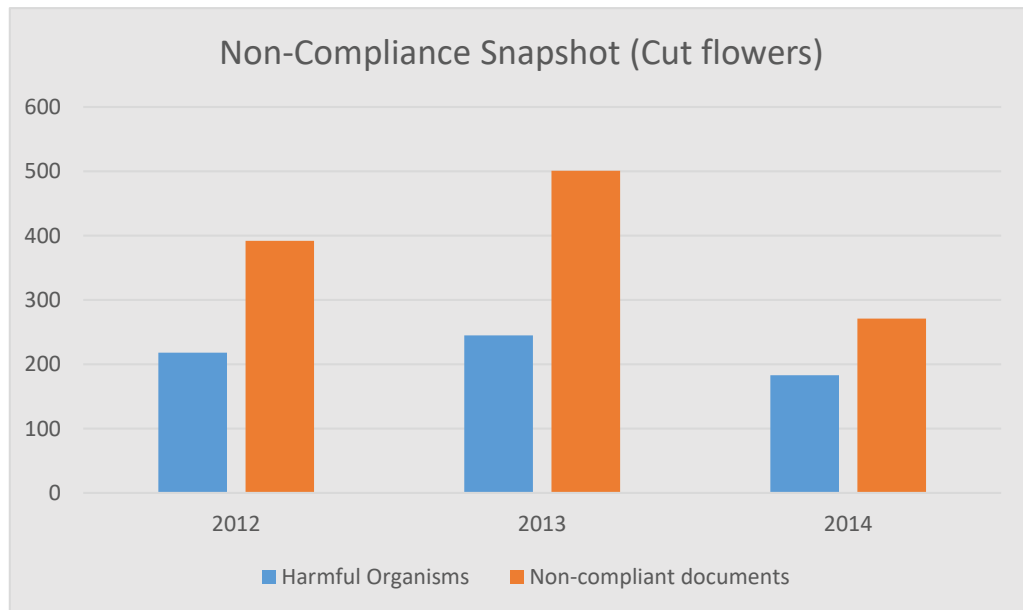

# Why ePhyto?



A 3-year survey showed non-compliant documents trigger a higher number of import rejections than actual plant health issues (harmful organisms)

- Reduces non-compliant certificates = More paper work rejections than pest finds.
- Eliminates inefficient paper processes = labor intensive.
- Reduces the re-issuance of paper phytosanitary certificates = tremendous cost in time and money with paper.
- Loss of commodities waiting for clearance.
- Reduces industry claims for late deliveries or bad quality.
- Improved security
- ePhyto protects legitimate trade.
  - Fraudulent certificates
  - Pest introduction

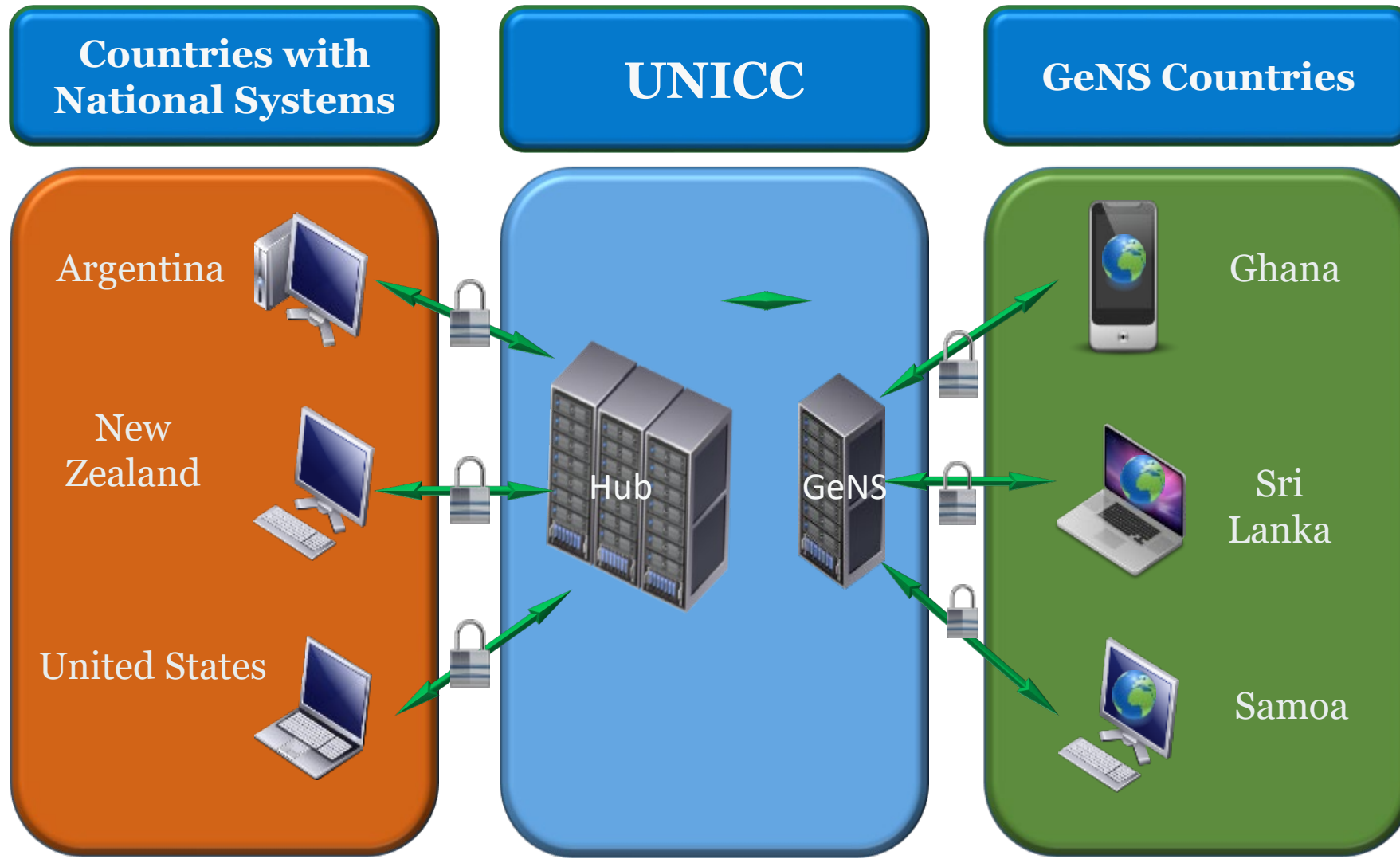

# ePhyto Case Studies

## 9 ePhyto case studies were completed last year

- Grain
- Seeds
- Fruit

## Reported savings due to ePhyto (case studies)

- 1-2 days in time
- At least \$25 US dollars per shipment just in mailing costs (DHL, FedEx, UPS, hand carry)

## Example of two held shipments resolved by ePhyto

- **Grain shipment**
  - \$36,000 saved
  - Shipment released within hours rather than days
- **Pomegranate fruit shipment**
  - Perishable shipment
  - Shelf life maintained

# What's Next with ePhyto?

## ePhyto Solution – Hub and GeNS

- Exchange Notices of Non-Compliance
- Inspection findings
- Other government systems (Single Window, Customs, ASYCUDA, etc.)
- Industry systems
- Further collaboration with SPS agencies (OIE and CODEX)
- Further collaboration with non-phytosanitary agencies (CITES, Global Alliance for Trade Facilitation)
- Routine maintenance and enhancements
- Translation in other languages (GeNS)
