13:15-14:45	Lebanon	Standard setting: Phytosanitary certification	Nico Horn on behalf of the IPPC ePhyto steering committee,  David Nowell,  Rebecca Lee,  Peter Johnston,  Nico Horn	<p>Title: Electronic Phytosanitary Certification: principles, progress update of IPPC ePhyto working groups and demonstration</p> <p>Summary: Following an IPPC workshop in Seoul in 2011, working groups have developed further harmonisation of electronic phytosanitary certification. This effort is reflected in a draft Appendix 1 to ISPM12 that will be submitted to the SC to follow the process of approval within IPPC, including member consultation. In this side event these elements of harmonised ePhyto will be explained from the point of view of NPPOs touching on the IT elements involved, in a way that is understandable to thnon-IT people of NPPOs. Furthermore, the exchange of electronic phytosanitary certificates will be demonstrated live to show how it works. It will also be demonstrated that the electronic data can be printed in a format comparable with a common paper certificates, which may be useful in the process of import inspection or re-export. The objective of the side event is to increase the understanding of electronic phytosanitary certification (ePhyto): what elements are important in ePhyto, how it can be applied and what the benefits are. This will help the process of IPPC approval, including the member consultation of the draft Appendix 1 of ISPM12. Furthermore, this will help to achieve the wider implementation of ePhyto among member countries.</p>

			Plant Protection Service, Netherlands Food and Consumer Product Safety Authority	<p>Summary: Q bank (<a href="http://www.q-bank.eu">www.q-bank.eu</a>) consists of a dynamic open-access database of quarantine plant pests and look-alikes, including invasive plant species. The database is linked to curated and publicly accessible reference collections. The database contains sequence data, morphological data including photographs, nomenclatural and diagnostic data. Q-bank also includes different tools which can help diagnostic specialists. Polyphasic identification and digital keys for the identification of invasive plants can be used through Q-bank.</p> <p>Reference collections are an indispensable part of phytosanitary research and diagnostics. Access to these collections and identification of taxonomic specialists is often problematic. To keep up the quality of the phytosanitary work it is urgent to join forces to readily disclose relevant data. Q-bank is an interesting tool to connect reference collections in Europe and in that way to help the quality of phytosanitary diagnostics and research.</p> <p>Q-bank is a Dutch initiative. The database is supported by an international group of European curators. Through this side-event we hope to achieve further international recognition and participation, amongst curators and users of Q-bank, and in the management of the database. Only then Q-bank will become a valuable tool for phytosanitary purposes.</p>
