IPPC Standard setting work programme (with proposed adjustments)

Agenda Item 9.4 of the Provisional Agenda

I. The IPPC Standard Setting Work Programme

1. Modified procedures and criteria for identifying topics for inclusion in the IPPC standard setting work programme were adopted by the Commission on Phytosanitary Measures (CPM) in 2008. According to this procedure, the Informal Working Group on Strategic Planning and Technical Assistance (SPTA) reviews submissions for new topics for the standard setting work programme and recommends strategic priorities for new standards to the Standards Committee (SC). The SC then makes recommendations to the CPM for new topics and their associated priorities, as well as any other adjustments to the work programme that the SC felt were needed.
2. A topic, once put on the standard setting work programme, remains there until the standard has been developed and adopted, or removed by the CPM. Additional topics and/or subjects developed under technical panels (TPs) are also part of the standard setting work programme. The CPM can, at its discretion, adjust the standard setting work programme.
3. The IPPC standard setting work programme as of December 2009, along with the proposed adjustments outlined below, is given in Annex 1. The work programme in Annex 1 is ordered by the proposed date of adoption to show the predicted volume of standards that will be presented to the CPM each year. Proposed adjustments are highlighted with a shaded background.

II. Biennial Call For Topics for the Work Programme

4. The IPPC Secretariat made a biennial call for topics for the IPPC standard setting Work Programme in May of 2009. The call was sent to contracting parties, NPPOs, RPPOs, the WTO-SPS Secretariat and other relevant international organizations, and was also posted on the International Phytosanitary Portal (<https://www.ippc.int>). The IPPC Secretariat received 22 submissions from contracting parties, one international organization (International Seed

Federation) and three technical panels (Forest Quarantine, Fruit Flies and Phytosanitary Treatments).

5. The SPTA reviewed the submissions and identified strategic priorities for consideration by the SC. The next biennial call for topics will be made in 2011.

III. Adjustments to the IPPC Standard Setting Work Programme

6. At the November 2009 SC meeting, the SC reviewed the work programme keeping in mind the strategic priorities identified by the SPTA and suggested adjustments to the IPPC standard setting work programme for CPM consideration.

7. The SC agreed to the recommendations from the SPTA that there is a need to change priorities from high to normal for the following topics: *Pre-clearance for regulated articles* and *Systems for authorizing phytosanitary activities*.

8. The SC also agreed that:

- the new topic of *International movement of seed* be added to the work programme with a high priority. It was noted that when the specification for this topic is developed, the SC should consider how re-export issues are handled in the revision of ISPM 12 (*Guidelines for phytosanitary certificates*)
- revision of ISPMs 4 (*Requirements for the establishment of pest free areas*), 6 (*Guidelines for surveillance*) and 8 (*Determination of pest status in an area*) be added to the work programme with a high priority for ISPM 4 and a normal priority for ISPM 6 and 8.
- the new topic of *Establishment and maintenance of regulated areas upon outbreak detection in fruit fly free areas* be added to the work programme with a normal priority.
- the new topic of *Biological control for forest pests* be added to the work programme with a normal priority.
- the new topic of *Soil and growing media in association with plants: treatments* be added to the work programme with a normal priority.

9. The SC reviewed the TPPT recommendation in response to the formal objection received on the irradiation treatment for *Omphisia anastomosalis* and agreed with the TPPT recommendation to remove this treatment from the work programme, as there is insufficient data to support this treatment at this time.

10. The SC reviewed the balance between concept and specific ISPMs, as requested by the CPM. It was noted that almost all adopted ISPMs are concept standards, but that the majority of standards under development now are considered to be specific standards. No action is needed to increase the number of specific standards because specific standards are already under development.

11. Discussions on topics and priorities for standards are recorded in the reports of the SPTA (<https://ippc.int/index.php?id=125447>) and the SC (<https://www.ippc.int/index.php?id=13355>) meetings.

12. In summary, the SC recommended the following additions, deletions, revisions and changes to the standard setting work programme under the regular standard setting process (priority indicated in brackets):

- Addition of *International movement of seed* (high).
- Addition of *Biological control for forest pests* (normal).
- Addition of *Establishment and maintenance of regulated areas upon outbreak detection in fruit fly free areas* (for inclusion as Annex 1 of ISPM 26) (normal).
- Addition of *Soil and growing media in association with plants: treatments* (normal).
- Revision of ISPM 4. 1995. *Requirements for the establishment of pest free areas* (high).
- Revision of ISPM 6. 1997. *Guidelines for surveillance* (normal).

- Revision of ISPM 8. 1998. *Determination of pest status in an area* (normal).
 - Change in priority from high to normal for the following topics: *Systems for authorizing phytosanitary activities* and *Pre-clearance for regulated articles*.
 - Deletion of the irradiation treatment for *Omphisia anastomosalis*.
13. Both the SPTA and SC noted that the standard setting work programme requires long-term planning and that new additions are important to ensure an adequate number of topics for an ongoing work programme.
14. Standards submitted to the CPM for adoption through the regular and special standard setting processes are given under agenda items 9.2 and 9.3, respectively.

IV. Member Consultation 2010

15. In November 2008, the SC agreed with the recommendation by the Secretariat that there be a combined consultation period for both regular and special processes. During the June-September 2010 member consultation period, regular and special process consultations will again be combined.
16. To ensure a manageable volume of documents sent for member consultation, the Secretariat, in consultation with the SC to set priorities, will again endeavour to submit the equivalent of five draft ISPMs (including diagnostic protocols, treatments or concept ISPMs) for member consultation. Although the Secretariat is building an online comment system, if the system is not ready for the 2010 member consultation period, members may again be requested to volunteer their services to help compile comments.
17. The CPM is invited to:
1. *Adopt* the addition of revisions of ISPMs and their associated priorities, as highlighted in Annex 1.
 2. *Adopt* the addition of new topics and their associated priorities, as highlighted in Annex 1.
 3. *Adopt* changes in priorities from high to normal for the following topics: *Pre-clearance for regulated articles* and *Systems for authorizing phytosanitary activities*.
 4. *Note* the deletion of the irradiation treatment for *Omphisia anastomosalis* as highlighted in Annex 1.
 5. *Note* that the Secretariat will again conduct the member consultation periods for the regular and special processes concurrently in June- September 2010.
 6. *Note* that the Secretariat, in consultation with the SC, will submit the equivalent of five draft ISPMs for member consultation in 2010.
 7. *Request* members to consider volunteering to compile comments if necessary.
 8. *Note* that calls for nominations of experts will be made for expert drafting groups to develop standards on topics on the standard setting work programme, and *encourage* submission of nominations of experts by NPPOs and RPPOs.
